A. Franchise renewal agreement with Spectrum Communications Cable T.V. – Mayor and Supervisor Tague met with CATV negotiators Steve Shaye and John Figliozzi for an update on franchise renewal. Basically, Spectrum pulled the proposed contract when they learned there was head-to-head competition with Midtel in Schoharie and Middleburgh.
