### 8:00 HEARING – Local Law #1-2016 Authority to Override the Tax Cap

<u>Motion</u> made by Trustee August second by Trustee Balliett unanimously carried to open the 8:00PM Hearing for Local law #1-2016

<u>Mayor Borst</u> read out loud the Public Notice then explained the Local Law how it is a precautionary measure that the Village has done every year since Hurricane Irene and if the Village does not exceed the Tax Cap the Village will then rescind the Local Law.

## **Old Business:**

- A. Consolidated Funding Application (CFA) -2015:
  - 1. Review the contract documents from ESD and set up next steps for implementation of 2015 \$300 K CFA award?
  - 2. Facilitator? Trustee Caza will contact Harry Sicherman tomorrow to act as a facilitator for this project
- B. Consolidated Funding Application (CFA) **2016**:
  - Need to schedule meeting to formulate approach for new CFA round in June 2016. Discuss who/what people and organizations involved including grant writer. Mayor will email Nan Stolzenburg, Harry Sicherman and the CDC Board to organize a meeting to discuss the 2016 CFA
- C. Local Waterfront Revitalization Plan (LWRP)
  - 1. Discussion on review of proposed zoning regulations and the revised version(s) for waterfront areas and campground areas. Don should talk to Floyd Guernsey about changes to his campground plans such as W/S and pads for campers
- 2. Per Nan's e-mail, should her company have another meeting to discuss some alternatives to some zoning proposals regarding campgrounds? A meeting needs to be set up with Nan once the water capacity is known
- D. Birches Services Agreement approval The Birches senior housing project requests to enter into a services agreement with the Village of Schoharie which, in lieu of a PILOT, would result in a benefit payment to the Village. Town of Schoharie has to approve exemption contingent on approval of Benefit Payment agreement. \$325.00 \* 72 for a total of \$23,400.00 units is the amount of the service agreement for the first year the service agreement will go up every year as detailed in the service agreement. Mayor will recommend to the Town to approve the exemption contingent to the service agreement approval and to do it immediately because the Town needs to find out if at the end of the 30 year agreement will the Birchez still be exempt or will the Town have to revoke the exemption in order for the Birchez back on the tax roll.

### New Business:

A. Contract with Ian Law of PLACE Alliance for architectural services in conjunction with the Local waterfront Revitalization Plan. Ask Village Attorney Breen to review and, at the suggestion of Nan S., insert language that the fee cited is a not-to-exceed amount.

<u>Motion</u> made by Trustee Caza second by Trustee August unanimously carried to approve the contract with Ian Law contingent to Village Attorney, Mike Breen, reviewing and, at the suggestion of Nan Stolzenburg, insert language that the fee cited is a not-to-exceed amount.

B. Per Nan Stolzenburg: Update Comprehensive Plan with added Appendices reflecting adoption of LTCR and LWRP. Engage Nan Stolzenburg to help administer the procedural steps for review and adoption. This action should be done when the LWRP is completed and adopted which will allow the two new Village Board members to get up to speed on the entire planning initiatives. Target timeframe should be late April or early May when the LWRP should be finished.

<u>Motion</u> made by Trustee Caza second by Trustee August unanimously carried to include a directive to add LTCR and LWRP into the comprehensive Plan once they are completed and adopted.

- C. Neighbors concerns regarding work at Birches Senior Housing. Mayor Borst will make Code Enforcement Officer, Lloyd Stannard, aware that the water line easement, landscaping and the access road for the fire line is not finished
