# **Privilege of the Floor (POF):**

A. ### **Incoming Correspondence:**

- A. Uniform Tax Exemption Policy Amendments regarding Solar projects
  - **a.** Peter Johnson, a Director at IDA, addressed the Board regarding the New York State changes in regulation of Solar Farms and how it effects Schoharie County. Schoharie County currently has 10 proposals for Solar Farms equaling 120 Mega watts in energy. New York State has removed the home rule and will now be the deciding factor regarding these proposals. Schoharie County is concerned with the number of proposals and lack of ability to approve or deny preliminary proposals and wishes to institute a uniform policy within the county to charge a minimum of \$20,000 per megawatt with a 3% escalation for the first 10 years similar to a PILOT program. This money would be divided with 50% going to the school district, 40% going to the County and 10% going to the Town/Village where Solar Farm is located.

<u>MOTION</u> made by Mayor Caza second by Trustee Palmer with Trustee Johnson recusing himself, carried to approve supporting the amendment adopted by the Board of the Schoharie County Industrial Development Agency in Resolution Number 0221 in regard to commercial solar facilities.

- **B.** The Clerk's Office received a FEMA notice for 123 Bridge Street stating the structure is within a Special Flood Hazard area. The Village was put on notice that this property is under review.
- C. The Clerk's Office received a FEMA letter acknowledging the Village's letter in support of Niagara Engine's application for the F/Y 2020 Assistance to Firefighters Grant (AFG). Plan to review determination of who is eligible for the Grant will be held virtual later this spring.
- D. Clerk's Office received a letter from a resident in Cambridge, NY who is looking to move and inquired if the Village of Schoharie has or will have LED lighting in the Village. Mayor Caza along with Clerk/Treasurer Leslie Price will construct a letter in response to her inquiry.
- E. Clerk's Office received an E-mail from Bobbi Wayman, Event Chair for Marathon for a Better Life asking the Village to purchase luminaries for this event. While the Village can not purchase these luminaries, Clerk/Treasurer Price will post on the Village Website and contact the Chamber of Commerce regarding this event. She will also try to contact local businesses.

#### **New Business:**

**A.** DPW Superintendent Kenneth Bernhardt has completed his one-year employment and should receive an increase in salary in accordance with his employment contract. Clerk/Treasurer needs a motion to adjust the budget line items for a salary increase of \$3,000.00 as follows: Move \$840.00 from A12104 to A51101, move \$1,020.00 from F83104 to F83301 and move \$1,140.00 from G81104 to G81301.

<u>MOTION</u> made by Mayor Caza second by Trustee Medak unanimously carried to approved adjusting the budget line items for a salary increase of \$3,000.00 for DPW Superintendent Kenneth Bernhardt.

#### **OTHER:**

- A. Deputy Mayor Johnson informed the Board that he has talked to Jim Becker regarding updating/improving Broadband and wireless in the Village with the NYS stimulus money.
- B. Deputy Mayor Johnson spoke to Bob Vedder from Kiwanis about a drive through chicken BBQ at Fox Creek. A Permit will need to be issued.
