### 1. Privilege of the Floor:

Mr. McFee lives on Sunset Drive and may be impacted by the Trail depending on the final project plans. Mr. McFee is concerned with the Trail and the South end Drainage project. Trustee Johnson mentioned investing in Treasury Bonds and NYCLASS as the rates are a little high than government money markets.
