**Privilege of the Floor: (POF):** 

1. James Cook purchased the home at 130 Fair Street and is requesting an adjustment to his June 1, 2019 Tax Bill. When he made a final payment on June 26<sup>th</sup> to the County for this property, he was handed a Tax Bill with delinquent Water/Sewer bills. His intention is to return this property to a Two-Family Home.

<u>Motion</u> made by Trustee Johnson second by Trustee Wood unanimously carried to remove the delinquent Water/Sewer on this property and allow payment and late fee on the Village Tax Bill of \$495.96.

- 1. Ben Griffin had concerns about the sidewalk crossing by Great American, questioned if there are plans for a sidewalk from 459 Main Street to Fox Creek Park. Mayor Caza did mention that it is listed in the application of the Trail Project. Mr. Griffin asked for a list of residents that do not mow their lawns and or shovel sidewalks also asked if it would be financially beneficial to the Village if bids were sent out for the mowing and snow removal of properties of residents that do not comply with Village Codes, rather than put this responsibility on DPW. Clerk/Treasurer will get a list of these properties when she receives the information. Board will discuss the possibility of getting bids for mow/snow. Ben also asked if the mound of grass around near the sidewalk by the Gym parking lot if this was a code violation. Trustee Palmer will look into this when Board members walk the Village site.
- 2. Terry Wilbur asked who takes care of the grass in the grates that are around the trees on Main Street. Mayor Caza responded, DPW
- 3. Mary Manchester asked about the drainage project. Mayor Caza responded that this project is not yet completed. He asked Clerk/Treasurer to contact Mike Harrington and Simmons Recovery to see what is left on this project and ask if the road will be repaved. She also mentioned that her new assessment lists her property at 110 Knower Ave as Residential Vacant Land and Southeast Drainage told her it is wetlands. Mayor Caza said he would talk to the Assessor. Ms. Manchester was also concerned about the poor drainage on the Spencer Motschmann property located at 184 Main St. The Board's understanding is that Spenser is supposed to put in more drainage to fix this problem.
