## **Privilege of the Floor: (POF):**

John Wilkinson Followed up on asking the Village Board for financial assistance for Colonial Heritage which manages seven museums in Schoharie. Trustee Johnson had reviewed Invoices and concluded that Colonial Heritage has constant updating and upkeeping on these properties and they have applied for Grant money to help with the cost. Trustee Johnson suggests the Village provide \$500.00 to Colonial Heritage plus have the Village help with snowplowing and grounds keeping for the remainder of this fiscal year. The Mayor and Board will review again in next year's budget. DPW will plow the parking lot at Depot Lane and the Creamery Building as well as the Station House Loop.
