Meeting brought to order: By Mayor Caza at 6:35 PM

Pledge of Allegiance

1. Privilege of the Floor:

- **a.** Mike Harrington from Lamont Engineers See attached Report.
 - i. Mike asked that the Board approve, and the Mayor sign the Engineering Contract Amendment Number 2 for Design and Construction Phase Services for the Water Improvement Project.
 - **ii.** Construction on the new Water Tank is completed. Mike had a conversation with Superintendent Ken Bernhardt regarding a new tank level transmitter unit for the new tank. The Village is still using the old water tank at this time. DN Tanks submitted a change order to drain ground water near the base of the new tank where there is a leak. The estimated cost of the change order which will include repairs to the leak will be \$5,000.00.
 - iii. All the houses on Brookside are now being served off of the new Main. Tech Industries will be back tomorrow to start clean-up.
 - **iv.** About half of the Easements for Orchard and Depot have been received. Depot Lane ROW has been executed and recorded. The County piece has been signed and notarized.
 - v. Tech Industries is asking for a Payment #2 of \$25,000.00.

Motion made by Trustee Robinson-Bullock second by Trustee Johnson unanimously carried to approved to have Mayor Caza sign the Engineering Contract Amendment Number 2 for Design and Construction Phase Services for Water System Improvement Project and authorize Payout #2 for Tech Industries in the amount of \$25,000.00.

b. Julie Pacatte from SEEC

i. Julie was at the Board Meeting representing Harva Company Inc. and requested that the Village assist Harva on a CDBG \$100,000.00 Loan. Harva will be investing a half million dollars in equipment, payroll and job creation with training programs. While retaining 19 jobs they will also be creating 4 new positions. SEEC will assist the Board with this Grant. The first step is to hold a Public Hearing at the January 9, 2024, Board Meeting.

Motion made by Trustee Medak second by Trustee Palmer unanimously carried to approve the Village to sponsor Harva Grant Application and for the Village Clerk to advertise a public hearing at the January 9, 2024, Board Meeting.

- c. Dr, Elbialy.
 - i. Dr. Elbialy gave the Board an update on his progress. At the last Planning Board meeting there was no change, and the Vote was still NO. Another meeting is scheduled for the 18th. Dr. Elbialy's attorney is attempting to modify his application in the areas that cause concern for the Planning Board. He was told by the Planning Board to reduce his schedule or have patients wait in their cars. If he does use the parking space across the street, he wants to ensure that the Crosswalk is improved with lines and lights. The Planning Board also suggested that Dr. Elbialy do a traffic study which would cost approximately \$5,000.00. Dr. Elbialy asked what kind of impression this gives to future investors in the Village. Mayor Caza appreciated Dr. Elbialy bringing his concerns to the Village Board but noted that the Planning Board is a separate entity. Mayor Caza did inform the public that there will be some open positions in both the Planning and Zoning Boards and interested parties should send a letter of intent along with a brief bio to the Village Office. Mayor Caza also requested that the Village Clerk, when posting the Public Hearing for January, also mention the open positions on both Boards.
